Judge Jamel Tabao Mamutuk is the Presiding Judge of Branch 44 and Executive Judge of the Regional Trial Court (RTC) of Initao, Misamis Oriental. He concurrently serves as Acting Presiding Judge of the 2nd Shari'ah District Court (SDC) in Bongao, Tawi-Tawi, and the 3rd SDC in Zamboanga City.

He was previously designated as the Acting Presiding Judge of RTC Branch 192 in Marikina City. Before his promotion to the RTC, he served as Presiding Judge of Branch 4, Municipal Trial Court in Cities, Iligan City. He is a Professorial Lecturer at the Philippine Judicial Academy (PHILJA), where he is also a member of the Department of Shari'ah and Islamic Laws and Jurisprudence.

Judge Mamutuk placed 3rd in the 2008 Special Shari'ah Bar Examinations (SSBE) and served as a Shari'ah Bar Examiner in the 2024 SSBE. He lectures in the Shari'ah Training Seminar (STS) conducted by PHILJA and the National Commission on Muslim Filipinos (NCMF), and is a Bar Reviewer for the Shari'ah Bar Review at the University of the Philippines – Diliman Institute of Islamic Studies (UP-IIS) and NCMF.

In 2023, he was invited by the Sindh Judicial Academy and American Bar Association Rule of Law Initiative to serve as a trainer for the National Training Workshop on Muslim Family Laws in Karachi, Pakistan. That same year, and again in 2024, he was a presenter at the 1st and 2nd National Shari'ah Summit organized by the Supreme Court of the Philippines.

Judge Mamutuk was the National Leader of the Philippine Delegation to the 46th Ship for Southeast Asian and Japanese Youth Program (SSEAYP), an international exchange program that fosters friendship and understanding among youth from ASEAN and Japan through cultural exchange and dialogue in 2019.

He also holds professional licenses as a Certified Public Accountant (1996) Civil Service Executive Eligible (2001) and Professional Teacher (2002). He earned his BS Accountancy, Juris Doctor, and Master of Public Administration degrees from Mindanao State University, where he now teaches at the College of Law. He completed all academic requirements for the Doctor of Public Administration at Western Mindanao State University (WMSU) and is currently writing his thesis for the Master of Arts in Islamic Studies at the University of the Philippines – Institute of Islamic Studies (UP-IIS).

Judge Mamutuk is married to Atty. Aelan Biruar Arumpac, and they are blessed with four (4) children, namely: Nageena, Ageel, Akiko and Anamta.
